

Parliamentary Report 2023 Issue 1: January

1 Report Highlights

In the news

- Online Safety Bill During Parliamentary scrutiny of the Online Safety Bill, a group of Conservative MPs secured the Government's agreement to <u>strengthen the sanctions for senior managers</u> at technology firms. In addition to fines imposed on firms, mangers will be criminally liable for repeated breaches of their duty of care to children and could face up to two years in jail.
- **Spiking** The Government has said it will not introduce new laws on spiking. Almost <u>5,000 reports</u> of needle and drink spiking were made to UK police forces over the course of 2022. The Government argue that there are already several offences which cover spiking incidents and it had not found any gap in the law.
- Harm to women from medical interventions In its <u>report</u> published on 20 January, the Health and Social Care Select Committee says that the Government must act urgently to enable women and children avoidably harmed by medical intervention (such as surgical mesh and sodium valproate taken during pregnancy) to receive compensation and care.
- Channel 4 Privatisation Culture Secretary, Michelle Donelan, has.reversed.proposals set out by her predecessor in Boris Johnson's government to sell Channel 4. Instead, she is making modest tweaks to the broadcaster's remit, with the business continuing to be owned by the state.
- Single Use Plastic Environment Secretary, Thérèse Coffey, has <u>announced a ban on single-use plastic</u> including plates, trays, bowls, cutlery, balloon sticks, and certain types of polystyrene cups and food containers from October 2023, allowing businesses time to prepare.

3 Closed Consultations: Government Response Published (click link for report)

- <u>Making flexible working the default</u> Government will make it a right to request flexible working from day one of employment when Parliamentary time allows. Businesses will be required to consult with their employees and explore the available options before rejecting a request. Employees will be able to make two flexible working requests within a 12-month period and employers must respond within two months. Employees will no longer have to set out how the effects of their flexible working request might be dealt with by the employer.
- Review of Net Zero The clear message from businesses, organisations, individuals, and local government across the country was that net zero is creating a new era of opportunity, but government, industry, and individuals need to act to make the most of the opportunities, reduce costs, and ensure delivery. It emphasises that the UK must go further and faster to realise the economic benefits of net zero and makes recommendations to enhance the role of local authorities, communities, and individuals to deliver net zero. It makes recommendation on short, medium, and long-term actions.

• <u>Introduction of a Deposit Return Scheme</u> – The Government will introduce a Deposit Return Scheme. 83% of respondents expressed support for it. The next phase will be to work through development of the legislation, taking necessary steps to ensure it will work in practice, and appointment of the deposit management organisation, followed by set up and roll out. No timeframe has been set.
